

A WARM WELCOME TO THE GARDEN OF THE PERMEKE MUSEUM

WE HOPE YOU WILL ENJOY YOUR VISIT AND REQUEST YOUR ATTENTION FOR A FEW RULES REGARDING VISITS TO THE GARDEN. THESE RULES ARE INSPIRED BY A CONCERN FOR SAFETY, RESPECT FOR OTHER VISITORS AND THE ENVIRONMENT, AND COURTESY.

THESE REGULATIONS ARE ALSO AVAILABLE FROM THE RECEPTION DESK OF THE MUSEUM AND ON OUR WEBSITE. EVERY VISITOR WHO ENTERS THE GARDEN IS DEEMED TO BE IN AGREEMENT WITH THESE REGULATIONS AND MUST BEHAVE ACCORDINGLY.

ENTRY

The garden is accessible from Tuesday to Sunday, from 10 am to 6 pm from 1 April to 30 September, and from 10 am to 5.30 pm between 1 October and 31 March. Both the museum and the garden are closed on Mondays, and at Christmas and New Year.

Access to the garden and use of the loungers is free of charge. A visit to the garden does not entail any obligation to visit the Permeke Museum, for which a ticket must be purchased.

Children under 12 must be accompanied.

The garden is not accessible during stormy weather or heavy rainfall.

SCULPTURE PARK

Please treat the sculpture park with the necessary care. We ask you not to touch the sculptures, and not to sit or climb on them.

FLORA AND FAUNA

Enjoy this green area. You may walk on the grass, but it is prohibited to pick plants, flowers or fungi or to use them for consumption. No marks may be made on trees or paths. Do not damage either the vegetation or the equipment in any way.

You may picnic anywhere in the garden, but we ask you to note the following:

- Visitors must take their refuse with them
- Barbecuing is prohibited
- Camping is not allowed
- The use of gas burners or other heating appliances is not allowed
- And please do not play loud music or shout

Pets are welcome but do ensure that your dog does not do its business in inappropriate places and always remove the mess. Bring enough bags with you. And keep your dog on the leash at all times.

It is prohibited to swim in the pond at the back of the garden. Please do not allow pets to swim there either.

TRANSPORT

- All motorised vehicles are prohibited in the garden, except for motorised mobility aids for persons with a disability.
- If you come by bicycle, electric bicycle, or scooter, we request that you leave your vehicle in the space provided for that purpose at the front of the museum during the opening hours of the garden. Vehicles should be secured in such a way as to make theft more difficult.
- Wheelchairs and children's prams and pushchairs are allowed in the garden. Prams and pushchairs may not be left behind in the garden.

PHOTOGRAPHY

Both the garden and the sculptures may be photographed. However, if these photos, videos or films are intended for professional purposes, prior written agreement must be obtained via info@muzee.be. Permeke's works are subject to copyright. If said photos, videos or films involve temporary installations, the photographer or filmmaker must check whether or not copyright applies. Payment of the copyright due is the sole responsibility of the photographer or filmmaker and cannot ever be recovered from Mu.ZEE and the Permeke Museum.

DISASTERS

In the event of fire, accident, evacuation, etc, visitors must follow the directions of the museum staff. Re-entry into the garden without their prior agreement is prohibited.

Accidents or injuries should be signalled to the museum staff immediately for registration, examination and possible treatment. The Permeke Museum cannot be held liable if the staff has not been informed immediately.
